



GILLS LANDING CAMPGROUND


The Gill's Landing Campground has twenty-one concrete RV sites. Each site is surrounded by lush green grass and shares a panoramic view of the South Santiam River. All RV sites have 30,40,and 50-amp power supplies. Concrete Walkways provide easy access to the restroom and shower facilities. A short paved trail connects the campground with River Park and provides access to it's various number of special events.

-PARK RULES-

Parks are open from dawn to dusk. Vehicles or patrons in park areas other than designated camping areas after dusk will be asked to leave.

Failure to comply with any park rule may result in loss of camping and/or park privileges. This loss of privileges may be in addition to any civil or criminal charges that may arise from violation of these rules.

Loss of camping and/or park privileges may result for failure to keep camp sites and picnic areas clean and orderly at all times. Further campers shall be responsible for any damage they may cause as a result of negligent actions.

It shall be unlawful for any person, firm or corporation, in or upon any lands designated by the City of Lebanon, Oregon, as city parks and recreation areas to:

1. Camp without a registered self-contained: trailer, truck mounted camper or motor home except in areas specifically designated. In such designated camping areas, stays shall be limited to fourteen days, in any four week period unless an authorized permit has been issued. A day is defined as a 24-hour period, including day and night. In specifically designated camping areas a camping fee shall be charged, payable by 1:00 P.M. or within one hour of occupying a site after 1:00 P.M. Check out time for campsites is 12:00 P.M. The City through the camp host reserves the right to terminate camping stays. Stays other than day use during the winter season shall be restricted to vehicles that are self-contained. Self-contained is defined as any vehicle that has manufacturer-installed toilet facilities.
2. Keep more than one vehicle or more than eight persons in one campsite. Monthly reservations are limited to not more than two persons per campsite. Extra vehicle parking is available and an additional daily fee will be charged and is payable at the same time as the initial space fee.
3. Operate radios, televisions, musical instruments, and other noise-producing devices at unreasonable volumes, or otherwise cause excessive, loud, or disruptive sound without prior authorization from the City. Quiet time in parks and campgrounds is from 10:00 P.M. until 7:00 A.M. Noisy and disruptive behavior by campers and/or their guests or other park patrons is not permitted and offending campers or other patrons are subject to immediate expulsion from the park upon notice by the camp host, Police or other City official.
4. Sleep on the park seats or benches; or make, assist in making, continue, or cause to be made any boisterous, disturbing, threatening, abusive, indecent, or obscene language or gestures or unnecessary noise; or by any other act to breach the public peace; or annoy, disturb, injure, or endanger the comfort, repose, health, safety, welfare, or peace of others while in any park or public facility.
5. Build, light, or maintain any fire except in a stove or pit, however, portable gas, charcoal and oil camp stoves may be used within the park in a safe operational condition.
6. Pick, mutilate, dig, or remove any plant, living or dead, or deface, mutilate, destroy, or defile any tree or plant within the limits of such areas. The cutting of trees or other woody plants in the park or park areas for firewood is prohibited.
7. Alter, deface, mutilate, or destroy any trail, road, parking lot, bridge, fence, building, sign, barrier, or other facility or structure. Dig up or remove any soil, stones, rock or other substances whatever, without City approval.
8. Dump household or commercial garbage or debris brought from outside the park or recreation area. Deposit any rubbish, glass, or other litter except in receptacles designated for that purpose
9. Drive a vehicle at a speed greater than is posted.
10. Drive or park any truck, trailer, or motorized vehicle anywhere except on roadways or other spaces specifically provided without prior authorization from the City.
11. Ride or operate a bicycle, scooter, skateboard, roller skates or rollerblades upon benches, upon picnic tables, alongside or under picnic shelters or alongside or under gazebos located within any city park or recreation area open to the public, except upon designated bike trails within said parks or recreation areas.
12. Keep or permit in such areas more than two animals. All animals must be kept in a vehicle or on a leash. Persons keeping such animals shall also be responsible for the removal of any excrement left by their animals. Animals may not be left unattended at any time. Abandonment of animals is prohibited. Abandoned animals will be impounded.
13. Consume distilled spirits in any park. No person shall enter or remain in a park or public facility while in a visibly intoxicated condition.
14. Drive any object into the ground (stakes, poles, posts, etc.) that could cause damage to underground utilities including irrigation systems.
